**ARTICLE 5 CAPITAL BUDGET/ARLINGTON HIGH SCHOOL
FEASIBILITY STUDY - MSBA
VOTED: (UNANIMOUS) (VOICE VOTE)**

That the Town appropriate the amount of Two Million (2,000,000) Dollars for the purpose of paying costs of the Arlington High School Project Feasibility Study ("Feasibility Study"), for Arlington High School located at 869 Massachusetts Avenue, Arlington, MA, including the payment of all costs incidental or related thereto, and for which the Town of Arlington may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the School Building Committee. To meet this appropriation the Treasurer, with the approval of the Board of Selectmen, is authorized to borrow said amount under and pursuant to M.G.L. Chapter 44 Section 7, or pursuant to any other enabling authority. The Town acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Town incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town and further provided that the appropriation hereunder shall be subject to and contingent upon an affirmative vote of the Town to exempt the amounts required for the payment of interest and principal on said borrowing from limitations on taxes imposed by M.G.L. 59, Section 21C (Proposition 2 1/2), and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Feasibility Study Agreement that may be executed between the Town and MSBA.
